



**TARGETEERS SPORTING GOODS**  
**AGREEMENT, RELEASE & WAIVER OF LIABILITY**

In consideration of being permitted to participate in or assisting others in participating in archery activities on premises of Targeteers SG II, L.L.C., d/b/a TARGETEERS SPORTING GOODS, and related events and activities, on behalf of myself, or a minor child or ward, heir, next of kin, personal representative, successor or assign:

- (1) I ACKNOWLEDGE, UNDERSTAND, DECLARE AND AGREE THAT:
  - (a) To the best of my knowledge, I am in good physical condition and have no disease or injury that would be aggravated by participating in activities related to archery.
  - (b) Participating or assisting others in participating in archery may involve RISK OF INJURY TO ME, INCLUDING DEATH, LOSS OR DAMAGE TO ME OR MY PROPERTY, or other consequences, which might result from my own actions, inaction or negligence but also the actions, inaction or negligence of others, the rules of play, or the conditions of the premises or of any equipment used;
  - (c) There may be OTHER RISKS not known or not reasonably foreseeable; and understanding all of the above.
- (2) I assume all of the above risks and release, waive, discharge, hold harmless, indemnify and covenant not to sue Targeteers SG II, L.L.C., d/b/a Targeteers Sporting Goods, its officers, directors, agents, representatives, employees, or volunteers, coaches, trainers or any other individuals associated with Targeteers Sporting Goods. I also release, waive, discharge, hold harmless and covenant not to sue the owners, lessors and lessees of the premises used to conduct the archery activities from ANY AND ALL LIABILITY FOR INJURY, INCLUDING DEATH, LOSS OR DAMAGE TO PERSON OR PROPERTY, OR ANY OTHER CONSEQUENCE arising out of participation in, performance in or lack of performance in, the archery activities.
  - (a) I assume the responsibility and the condition of my own equipment and or injury to others participating in activities related to archery.
- (3) I FURTHER AGREE THAT:
  - (a) Prior to participating in archery activities, I, or in the case of a minor, a parent or guardian, will INSPECT the facilities and equipment to be used, and if I believe same to be unsafe, I will immediately REPORT such condition(s) to the supervisor or manager and either DECLINE TO PARTICIPATE or ASSUME THE RISK of participating;
  - (b) I will ALLOW my PHOTOGRAPH, PICTURE or LIKENESS and/or VOICE to APPEAR in any documentary, promotional (including any and all advertisements), television, radio or film coverage of Targeteers Sporting Goods, WITHOUT COMPENSATION.
- (4) I CONSENT TO ALL EMERGENCY MEDICAL TREATMENT as may be deemed appropriate under existing circumstances by medical personnel or personnel associated with Targeteers Sporting Goods.
